## Gladys Noon Spellman Essay Scholarship



During March, Women's History Month, the Prince George's Office of the County Executive presents a scholarship in memory of Congresswoman Gladys Noon Spellman. Spellman was a celebrated county public servant for more than two decades; she was an

educator who later served as MD's US representative, for the fifth congressional district, from 1975 to 1981.

This year's scholarship essay application topic is: "Celebrating Women Who Fight for Diversity, Equity, and Inclusion," the 2024 Women's History Month theme.

### Applicant Eligibility:

- Be a resident of Prince George's County.
- Be in the 12th grade (accepted into college/pending).
- In-school and outside activities.
- Provide proof of community service.
- Have a GPA of 2.5 and above.

If selected, candidates must attend, in person, the Annual Women's History Month celebration (11 am to 2:30 pm), on Thursday, March 28, 2024, for scholarship presentations.

### Applicant Requirements

Application forms must be submitted via the WHML Portal and MUST include:

- Unofficial high school transcript copy.
- Copy of most current report card.
- Two (2) letters of reference (school counselor/teacher/administrator and another non-family member).
- Original essay response to prompt A or B (at [mypgc.us/whmlscholarship](http://mypgc.us/whmlscholarship)).

### Essay Requirements

- Minimum of 1,500 words, formatted in Times New Roman 12 point font and double-spaced.
- Examples of extra-curricular/community service activities (e.g., certificates, news clips) to support your application are welcomed.
- Applications are due **Friday, March 15, 2024, by 11:59 pm**. Incomplete and late applications will not be accepted; there will be no exceptions.

The unethical use of AI software in the creation of your essay is strictly prohibited. If you use AI software to research background for your topic, or use ideas or direct quotes from an AI search, your essay must have the appropriate in-text citations and include an appropriate reference page.

## County Housing Assistance Pilot Program for Seniors Launches in March

The Senior Housing Assistance Pilot Program will give eligible seniors up to two direct rent payments (\$2,500 total). The County Council passed senior living assistance legislation in 2023 and is working with Housing and Community Development to launch the program in mid-March 2024.

Eligible seniors meet these criteria:

- Renter aged 65 or older.
- Live in Prince George's County for 5-plus years.
- Household income cannot be greater than 40% of the Area Median Income (AMI). Furthermore, all mattresses and box springs must be wrapped in plastic or the trash company will not take these. Working together makes our neighborhood beautiful and welcoming!

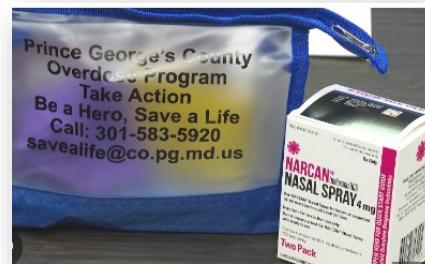
As well, as the weather warms up, our streets must remain clear for everyone's safety.

### File a Complaint about Mail Services

## 2024 Tax Returns Questions & Free Help

**What if I'm not ready by April 15?** If you need more time to file, you may apply for an extension until October 15; however, you must pay estimated taxes owed by April 15 with your extension application.

### Should I wait to file taxes with 2024 child tax credit?

Until the legislation is signed into law, you may wonder if you should hold off filing your return. In testimony before the House Ways and Means Committee on February 15, IRS Commissioner Daniel Werfel said, "*Taxpayers should not wait for this legislation to file their returns.*"

### Free Tax Prep Assistance

The IRS's Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE) programs offer free basic tax return prep to qualified individuals. The VITA program has operated sites for more than 50 years. To qualify for assistance a taxpayer must:

- Generally make \$64,000 or less;
- Have a disability; and/or
- Have limited English-speaking skills.

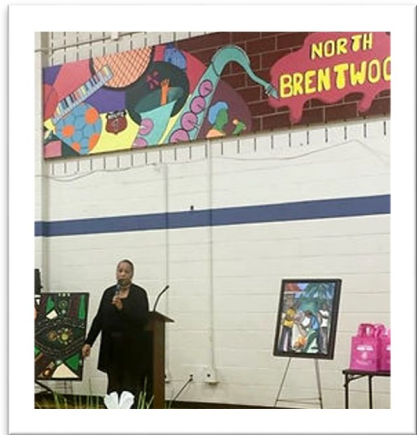
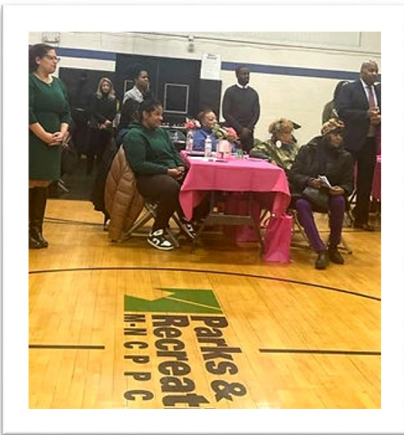
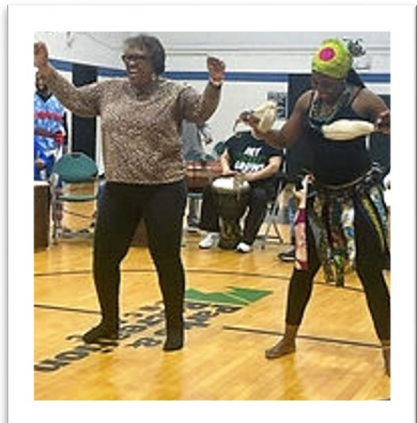
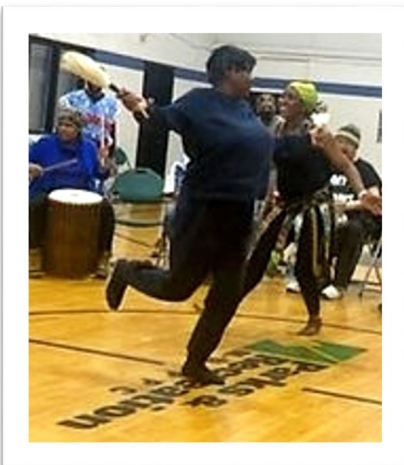
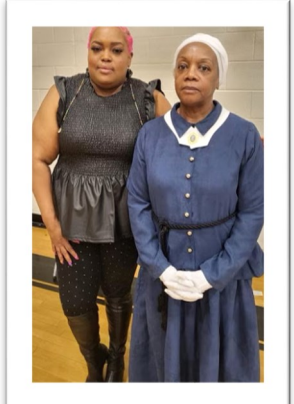
In addition to VITA, the TCE program offers free tax help (especially for those who are 60+) specializing in questions about pensions and retirement issues. The IRS manages VITA/TCE, but sites are operated by IRS partners and staffed by IRS-certified volunteers.

VITA/TCE services are a trusted source for preparing tax returns. All VITA/TCE volunteers, who prepare returns, must pass tax law training meeting or exceeds IRS standards, including maintaining the privacy and confidentiality of taxpayer information.

In addition to demanding volunteers to certify their knowledge of tax laws, the IRS requires a quality review check for every return prepared at a VITA/TCE site prior to filing. Each filing season, tens of thousands of dedicated VITA/TCE volunteers prepare millions of federal and state returns. They also assist taxpayers with the preparation of thousands of Facilitated Self-Assistance returns.

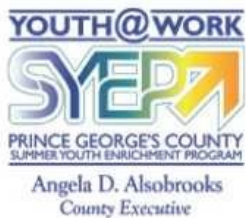

## DC's Annual Cherry Blossom Festival

The Washington, DC Cherry Blossom Festival is a spectacular event that celebrates the blooming of cherry trees around the Tidal Basin; the 2024 event runs from March 20 to April 14. *For programming visit: [nationalcherryblossomfestival.org/all-events](https://nationalcherryblossomfestival.org/all-events).*

**Dates:** This year, peak bloom is predicted to take place March 23 to March 26. This highly anticipated period was predicted by the National Park Service at the February 29 festival kick-off press conference. Peak bloom is when 70% of the iconic blossoms open on the Yoshino cherry trees. Get updates about the peak bloom forecast around the basin at: [cherryblossomwatch.com](https://cherryblossomwatch.com).

While the blooming period is difficult to predict more than ten days in advance, the festival has so much to offer, throughout a City in Bloom, no matter when the cherry blossoms open. The full blooming period lasts from several days to up to two weeks, depending on weather conditions.

**Events:** The festival typically features a variety of events and activities, including a parade, cultural performances, art exhibits, and fireworks. Check the festival schedule and plan your visit accordingly.



**Tidal Basin:** The reservoir (above) is the focal point of the annual bloom. Take a leisurely stroll or rent a paddleboat to enjoy the blossoms from the water. Prepare for crowds, especially during peak bloom.

**Photography:** The cherry blooms create a stunning backdrop for photography. Bring your camera or

smartphone to capture the beauty of the blossoms, but be respectful of others and avoid damaging the trees or trampling on nearby vegetation.

**Picnics:** Pack and enjoy a meal under the cherry trees. There are designated picnic areas around the Tidal Basin where you can relax and take in the scenery.

**Transportation:** Due to the popularity of the festival, parking can be limited. Consider biking, walking or taking public transportation to the Tidal Basin to avoid traffic and parking headaches.

**Early Mornings and Evenings:** To duck the largest crowds, visit early in the morning or at dusk, when the lighting is soft and the atmosphere is more peaceful.

**Weather:** Be prepared for varying conditions, as spring in DC is unpredictable. Dress in layers; wear sunscreen, sunglasses and a hat to protect yourself from the sun.

**Respect the Environment:** Remember to respect the cherry trees and the surrounding environment. Avoid picking flowers or climbing on the trees, and dispose of trash properly to keep the area clean.

**Enjoy the Experience:** Above all, take the time to savor the cherry trees' beauty and the atmosphere of the DC Cherry Blossom Festival: a memorable, unique experience that draws visitors from around the world.

## How to Manage Blood Pressure

Blood pressure is typically recorded as two numbers, written as a ratio like this: 117/76. Read as “117 over 76” millimeters of mercury in a blood pressure gauge.

- **Systolic:** The top number, the higher of the two numbers, measures the pressure in the arteries when the heart beats (when the heart muscle contracts).
- **Diastolic:** The bottom number, the lower of the two numbers, measures arteries' pressure when the heart is resting between beats.



### Blood Pressure Categories

- **Normal:** systolic lower than 120 mm and diastolic lower than 80 mm.
- **Elevated:** diastolic 120 to 129; diastolic 80.
- **High (Hypertension Stage 1):** systolic 130 to 139, diastolic 80 to 89.
- **High Blood Pressure (Hypertension Stage 2):** systolic 140 or higher diastolic 90 or higher.
- **Hypertensive Crisis (call a doctor immediately):** systolic 180+ and/or diastolic higher than 120.

**Track Levels** — A high blood pressure diagnosis must be confirmed with a doctor, who should also evaluate any unusually low blood pressure readings.

### Tips for Lowering Blood Pressure

- **Eat Smart:** A healthy diet consists of veggies, fruits, whole grains, beans, legumes, nuts, plant-based proteins, and lean animal proteins (fish, seafood). Limit sugary foods/drinks, red or processed meats, salty foods, refined carbs, and fatty foods.
- **Move More:** Physical activity helps control blood pressure, weight and stress levels.
- **Manage Weight:** If you're overweight, even a slight weight loss can reduce blood pressure. Make smart choices and food swaps to build a healthy eating style. Watch calories and eat smaller portions.

- **No Nicotine:** Each time you smoke/vape, nicotine can cause a temporary increase in blood pressure.
- **Sleep Well:** Short (less than 7 hours) and poor-quality sleep are associated with high blood pressure.

### Tips to Celebrate National Nutrition Month

- **Explore New Foods:** Use March as time to try new fruits, vegetables, grains, and proteins. Experiment with international flavors and cuisines to keep meals exciting and nutritious.
- **Cook at Home:** At-home prep allows you to control what goes into your meals. Try making meals from scratch; use fresh ingredients, and involve your family or friends in the cooking process for added fun.
- **Plan Balanced Meals:** Aim for meals that include a variety of food groups, such as lean proteins, whole grains, vegetables, fruits, and healthy fats. Create balanced plate portions with lots of colorful veggies.
- **Stay Hydrated:** Remember to drink plenty of water throughout the day. Also incorporate hydrating foods like fruits (e.g., cantaloupe and watermelon) and vegetables into your meals/snacks.
- **Limit Processed Foods:** Minimize intake of takeout and packaged foods, which are high in added sugars, unhealthy fats, and sodium. Opt for whole, minimally processed foods whenever possible.
- **Practice Mindful Eating:** Pay attention to your body's hunger and fullness cues, and eat slowly to savor food flavors. Avoid distractions, like phones or TVs, while eating to fully enjoy your meals.
- **Get Active:** Pair healthy eating with regular exercise to support overall health and wellbeing. Aim for at least 150 minutes of moderate-intensity exercise per week, such as brisk walking, swimming, or cycling.

Did you know that Prince George's County's Rain Check Program offers rebates to homeowners, businesses and others to install best management practices (BMPs) intended to capture stormwater runoff? This training is designed to provide landscape professionals with practical hands on information on the seven Rain Check Rebate practices and processes. Special emphasis is placed on rain gardens, pavement removal and permeable pavement.

This all-day training teaches landscape professionals how to plan, design, construct and maintain Rain Check Rebate practices. Classroom exercises provide guidance on practice selection, site assessment and site selection. After completion of the classroom training, participants are eligible to sign up for Day 2, which will be a field day to further hone their skills and help install or assess stormwater BMPs. Participants who successfully complete both sessions (classroom training + field day) will be added to the County's public list of landscape professionals who have completed the Rain Check Rebate Contractor Training.
