Wes Moore, with running mate Aruna Miller (Maryland's first Lieutenant Governor to be an immigrant and woman of color), will be sworn in on January 18, 2023.

#### **Maryland Elects First Black Governor!**

Wes Moore has won Maryland's governor race: the son of a single-mother Jamaican immigrant, became the third Black governor in American history (after Deval Patrick in MA and L. Douglas Wilder in VA) and the first Black person in this state to hold the title. Also making history is Moore's running mate, former state delegate Aruna Miller, the state's first immigrant and woman of color to serve as Lieutenant Governor.

Moore, a political newcomer, is a longtime businessman and philanthropist. His background prepares him for Governorship, including being: a Johns Hopkins graduate and football player, a Rhodes scholar, an Army officer and paratrooper in Afghanistan, a White House fellow, a former investment banker, and CEO of the Robinhood Foundation, the US's largest poverty-fighting nonprofit.

The Governor-Elect's nearly two-year campaign focused on his personal story facing adversity. His book, *The Other Wes Moore*, begins at age three seeing his father

die from a misdiagnosed illness. Moore vows to work with police and local communities to usher in an era of public safety; he also plans to champion abortion access and have appointees reflective of the people. "Our administration will look like the state of Maryland. I want for everyone around the state of Maryland, when you look at all of our [eventually] cabinet and agency heads... to know they are going to be respected and represented in the decision-making process," Moore said. To date, Moore's appointments are Marylanders: Fagan Harris, Chief of Staff; Tisha Edwards, Secretary of Appointments; Eric Luedtke, Chief Legislative Officer; Helene Grady, Secretary of Dept of Budget and Management; and Amanda La Forge, Chief Legal Counsel.

Moore hews closely to a message of inclusion and progress: "We leave no one behind. And that is not just a mantra, it is a value statement. And it is not just a value statement. Come January, that will be the new mission of this state."

#### **Code Officer Cuffie's Corner**



J&L Towing has posted towing signs around Town, to

help mitigate illegal parking problems.

The fee is \$215, for vehicles less than 10,000 lbs., for the first 18 hours, plus a \$50 storage fee every additional 24 hours thereafter.





For vehicles heavier than 10,000 lbs., the fee is \$300 for the first 18 hours, after which a \$50 storage fee is charged every 24 hours.

Be aware... all cars and trucks with expired tags are subject to being towed.

Lastly, yard waste will continue to be picked up through mid-January, before a break until spring.

#### Mortgage and/or Utility Assistance

North Brentwood is accepting applications from residents for rental/mortgage and/or utility assistance. Our Residential Assistance program provides temporary relief to all eligible applicants who've experienced financial hardship during the pandemic.

Currently, North Brentwood pays a maximum of \$2,000 for rental/mortgage help and/or utility assistance.

Approved households will be able to reapply for more assistance in the future, pending available funds.

As of November 15, 426 Marylanders were recently hospitalized, and the positivity rate fell to 6.72%. K-N95 masks are still available at the Town Office.



#### **Peace Cross Rededication**



A rededication for the newly restored Bladensburg Peace Cross Memorial was held on Veterans Day 2022, featuring local and state elected leaders, e.g., current Governor Larry Hogan.

The Peace Cross, which was first dedicated on July 12, 1925 by the

American Legion, honors 49 county residents who lost their lives during World War I (1914-1918).

In 2019, the Supreme Court ruled the monument could remain on public land and does not violate the First Amendment's establishment clause. At Governor Hogan's direction, the State of Maryland filed an amicus brief in support of keeping the Peace Cross on public land.

#### **Utility Scam Awareness Month**

As the holidays approach, Pepco offers tips to help residents identify scammers attempting to steal money and personal information. Pepco generally sees increased reports of attempted scams during the holiday season, when targeted victims' stress and activity levels are high.

The ruse: trick customers into: providing personal and/or financial information, and making false payments under the pretense of keeping their service active.

Scammers are also attempting to swindle those still facing pandemic-related economic challenges, by pressuring families and businesses struggling with past-due balances.



Pepco has some tips to help identify scams:

Pepco will never come to customer's home or business to:

- Request immediate payment, especially with a prepaid cash card or cryptocurrency.
- Ask for a Pepco account number, or other personal info, such as a driver's license number.
- Disconnect service without previous written warning. If a person comes to your home/ business to disconnect service, call Pepco to discuss your account status.

Pepco will never *call* a customer to ask for:

- An account number.
- Personal information, such a Social Security number or bank information.
- A direct payment with a prepaid cash card.


To identify an actual Pepco employee, know:

- All field employees wear a uniform with the Pepco logo, including shirt and safety vest.
- Pepco employees visibly display a company ID badge with the logo and employee's name.

#### **METRO'S Silver Line Opens**

November 15 is set as the opening day for the Silver Line Extension! The added 11.5 miles of track

will connect Metrorail customers to Washington Dulles International Airport! The extension completes the 23 mile corridor's final phase that began in 2009. The line has five other stations and forms the spine for a burgeoning Northern VA tech corridor.



The Silver Line extension is the largest expansion of the Metrorail system in eight years.

#### **American Indian Heritage Month**



November is Native American Heritage Month or, as it is commonly referred to, American Indian and Alaska Native Heritage Month. It's a time to celebrate richly diverse cultures, traditions and histories, and to honor many important contributions of Native people: those descended from any of indigenous (original) people of North, South and Central America, and who maintain tribal affiliation or community attachment. Heritage Month is also an opportunity to educate the public about: indigenous tribes, the unique challenges Native Americans have faced, and continue to face, and the ways tribal citizens work to protect their cultures.

Historically, Native Americans and Alaskan Natives have a unique relationship with the federal government due to conflict and subsequent treaties. In 1986, US Congress passed a proclamation authorizing "American Indian Week;" and, in 1990, President Bush approved a joint resolution designating November 1990 "National American Indian Heritage Month." Since then, presidential proclamations have been issued annually to celebrate Native Americans.

Today, 28 states and many cities, rivers and lakes have names derived from Native heritage. As well, there are 574 federally recognized US tribes and 324 Native American reservations. Per the Census Bureau, 5.2 million American Indians and Alaskan Natives lived in the US in 2010 and 7.1 million in 2020. Projections cite 10.1 million American Indians and Alaskan Natives will live in the US by July 2060.

National Native American Heritage Month is filled with community gatherings, festivals, and government and educational activities. We encourage you to learn about Native Americans/Alaskan Natives' traditions and contributions to education, art, literature, science, sports, government, and technology: past and present.

#### **One-time Student Loan Debt Relief**

President Biden, Vice President Harris, and the US Department of Education announced a three-part plan, to help working and middle-class federal student loan borrowers transition back to regular payments, as pandemic-related support expires. This plan includes loan forgiveness of up to \$20,000.

The Department of Education (ED) will provide up to \$20,000 in debt relief to Federal Pell Grant recipients and up to \$10,000 to non-Pell Grant recipients.

Borrowers with loans held by ED are eligible for this debt cancellation, if their individual income is less than \$125,000 (or \$250,000 for households).

#### Step 1: Check if you're eligible

You're eligible for student loan debt relief if, your 2020 or 2021 annual federal income was below \$125,000 (individual or married, filing separately) or \$250,000 (married, filing jointly or head of household).

#### Step 2: Prepare

Log in to your StudentAid.gov account and make sure your contact info is up to date. Updates will be sent by both email and text message, so sign up to receive text alerts. If you don't have a StudentAid.gov account (FSA ID), create one to help manage your loans.

#### Step 3: Submit your application

The application is NOW AVAILABLE, on ed.gov, until until December 31, 2023.

\* UPDATE: Biden's student loan forgiveness plan is held up in litigation. File your application asap; but, make payment arrangements with your loan provider before January 1, 2023, when the current payments pause expires. Stay tuned for updates!









### A Season for Sharing in Fire Safety

Each year fires occurring in the United States during the holiday season will claim the lives of over 400 people, injure 1,650 more, and cause over \$990 million in damage and will account for 40% of all fires during this time period of October thru January.

The Prince George's County Fire/EMS Department wishes to remind everyone that by following some of these simple life-saving steps you can ensure a safe and happy holiday season.

<u>Holiday Decorations:</u> All decorations should be nonflammable or flame-retardant and placed away from heat vents.

<u>Wrapping Paper:</u> Never Put Wrapping Paper in a Fireplace. It can result in a very large fire, throwing off dangerous sparks and embers and may result in a chimney fire.

**Artificial Christmas Trees:** If you are using a metallic or artificial tree, make sure it is flame retardant.

**Candle Care:** Avoid Using Lit Candles, If you do use them, make sure they are in stable holders and place them where they cannot be easily knocked down. Never leave the house with candles burning. Never Put Lit Candles on a Tree. Do not go near a Christmas tree with an open flame - candles, lighters or matches.

Holiday Lights: Maintain Your Holiday Lights Inspect holiday lights each year for frayed wires, bare spots, gaps in the insulation, broken or cracked sockets, and excessive kinking or wear before putting them up. Use only lighting listed by an approved testing laboratory.

**Do Not Overload Electrical Outlets:** Do not link more than three light strands, unless the directions indicate it is safe. Connect strings of lights to an extension cord before plugging the cord into the outlet. Make sure to periodically check the wires - they should not be warm to the touch. **Do Not Leave Holiday Lights on Unattended.** 

**Preventing Christmas Tree Fire Hazards:** Special fire safety precautions need to be taken when keeping a live tree in the house. A burning tree can rapidly fill a room with fire and deadly gases.

Selecting a Tree for the Holiday: Needles on fresh trees should be green and hard to pull back from the branches, and the needle should not break if the tree has been freshly cut. The trunk should be sticky to the touch. Old trees can be identified by bouncing the tree trunk on the ground. If many needles fall off, the tree has been cut too long, has probably dried out, and is a fire hazard.

Caring for Your Tree: Do not place your tree close to a heat source, including a fireplace or heat vent. The heat will dry out the tree, causing it to be more easily ignited by heat, flame or sparks. Be careful not to drop or flick cigarette ashes near a tree. Do not put your live tree up too early or leave it up for longer than two weeks. We recommend that you water the tree 3 times a day and keep the tree stand filled with water.

**Disposing of Your Tree:** Never put tree branches or needles in a fireplace or wood burning stove. When the tree becomes dry, discard it promptly. The best way to dispose of your tree is by taking it to a recycling center or having it hauled away by a community pick-up service.
