If you have already applied and were confirmed eligible, DO NOT REAPPLY.

The Elderly Property Tax credit provides up to a 20% credit on your County property taxes, including the County portion of the Homeowners' and Homestead credits, for up to five years once eligibility criteria is met.

To be eligible for this tax credit beginning July 1, 2024, at least one owner must meet the following criteria:

1. The owner applicant must be at least 65 years of age (born on or before June 30, 1959), **AND**
2. The same owner must have owned and resided in the home as principal residence for at least the previous 10 consecutive years (on or before June 30, 2014), **AND**
3. The assessed value of the property must be \$515,000 or less.
