A RESOLUTION TO APPROVE THE TOWN'S ACCEPTANCE OF THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT NATIONAL CAPITAL STRATEGIC ECONOMIC DEVELOPMENT PROGRAM GRANT AGREEMENT NCS EDF-022-NBrentwood-00404

WHEREAS, the Department of Housing and Community Development (**DHCD**) approved the Town of North Brentwood request for a 4506 Rhode Island Avenue Parklet (**the Project**) in the amount of \$50,000. This agreement (**Attachment A**) is entered into by the Town of North Brentwood (**Grantee**) and the Department of Housing and Community Development, a principal department of the State of Maryland (**the Department**) effective as of the date signed and executed by the Department.

WHEREAS, the 4506 Rhode Island Avenue Parklet (**the Project**) is a vacant lot the site will be graded and renovated in order that its usage becomes a park for community use.

WHEREAS, the Town of North Brentwood will administer the program. The total costs of the program is **Fifty-Nine Thousand Dollars (\$59,000)** consisting of National Capital Strategic Economic Development funding in the amount of \$50,000 will be used for improvement and renovation of the vacant lot in addition to related designs. The Town of North Brentwood will contribute **Four Thousand Dollars (\$4,000) in cash** and **Five Thousand Dollars (\$5,000)** in-kind to the program.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Town Council of The Town of North Brentwood, Maryland hereby agrees and approves the Agreement between DHCD and the Town of North Brentwood, including a monetary grant in the amount of \$50,000.00 (DHCD GRANT ID NCS EDF-2022-NBrentwood-00404), according to the terms and conditions stated therein, which is attached hereto and incorporated by reference herein as Attachment B.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Town Council of the Town of North Brentwood, Maryland hereby agree and approves the Agreement between the DHCD and the Town of North Brentwood in the amount of \$50,000 attached hereto and incorporated by reference herein as Attachment A.

AND BE IT FURTHER RESOLVED, that the Mayor is hereby authorized to sign said Agreement and any other related instruments or documents on behalf of the Town to carry out the purpose and intent of this Resolution;


