

President's Day: February 19

Presidents' Day is a federal holiday celebrated on the third Monday in February; in 2024, it will occur on the 19th. The holiday was originally established in 1885 and celebrated on President George Washington's birthday (February 22). It became popularly known as Presidents' Day after it was moved as part of 1971's Uniform Monday Holiday Act, an attempt to create more three-day weekends for the nation's workers.

While several states still have individual holidays honoring the birthdays of Washington, Lincoln and others, Presidents' Day is now popularly viewed as a day to celebrate all US presidents, past and present.

Free Help with 2024 Tax Returns

- The IRS and Maryland began accepting all *Business* tax returns on 01/16/2024.
- The IRS and Maryland began accepting all *Individual* tax returns on 01/29/2024.

The IRS's Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE) programs offer free basic tax return prep to qualified individuals.

The VITA program has operated sites for more than 50 years. To qualify for assistance a taxpayer must:

- Generally make \$64,000 or less
- Have a disability; and/or
- Have limited English-speaking skills

In addition to VITA, the TCE program offers free tax help, particularly for those who are 60 years of age and older. It specializes in questions about pensions and retirement-related issues unique to seniors.

While the IRS manages the VITA and TCE programs, the sites are operated by IRS partners and staffed by volunteers who want to make a difference in their communities. The IRS-certified volunteers who provide tax counseling are often retired individuals associated with nonprofit organizations that receive grants from the IRS.

VITA/TCE services are not only free, they are also a reliable, trusted source for preparing tax returns. All VITA/TCE volunteers, who prepare returns, must pass tax law training that meets or exceeds IRS standards, including maintaining the privacy and confidentiality of taxpayer information.

In addition to demanding volunteers to certify their knowledge of tax laws, the IRS requires a quality review check for every return prepared at a VITA/TCE site prior to filing. Each filing season, tens of thousands of dedicated VITA/TCE volunteers prepare millions of federal and state returns. They also assist taxpayers with the preparation of thousands of Facilitated Self-Assistance returns.

Crossing Guard Emergency Staffing & Job Opportunities

In response to the shortage of the Police Department's School Crossing Guards (SCGs) in the county, the Alsobrooks Administration has implemented a coordinated, comprehensive emergency crossing guard staffing plan, effective immediately. Prince George's County Police Executive Command staff, along with police officers, will temporarily staff uncovered locations until dedicated crossing guards are hired.

In addition, the SCG unit is launching a robust recruitment campaign: distributing bilingual hiring flyers, using social media, engaging the faith-based community, collaborating with County Council members, partnering with Prince George's County Public Schools, and promoting the job posting through Employ Prince George's. Office of Social Equity and Cannabis Public Health Advisory Council Seeks PG's Members



Maryland's Department of Health has an Office of Social Equity and Cannabis Public Health. This body makes critical decisions to regulate the cannabis industry; it reportedly currently

lacks sufficient representation from Prince George's County on its Advisory Council.

The legalization and commercialization of marijuana has created hot button issues. Per *The Washington Post*, "While people overwhelmingly voted for legalization here, proposed rules are dusting up old associations with marijuana and invigorating an enduring debate about how to safeguard a reputation of prestige while meeting the growing needs of Prince George's County."

Tensions have also been high over opportunities for Black-owned cannabis businesses and anti-social-equity efforts to funnel new dispensaries away from high traffic retail locations. County Councilperson Wanika Fisher, and other dispensary advocates, say it was state lawmakers' promise of social equity measures that was a driving reason to pursue cannabis legalization.

As of January 2023, the Cannabis Public Health Advisory Council was authorized by MD's General Assembly. Among other things, the Council studies aspects of cannabis use on those under 21, including behavioral health, and education impacts.

County Housing Assistance Pilot Program for Seniors Launches in March

The Senior Housing Assistance Pilot Program will give eligible seniors up to two direct rent payments (\$2,500 total). The County Council passed senior living assistance legislation in 2023 and is working with Housing and Community Development to launch the program in mid-March 2024.

Eligible seniors meet these criteria:

- Renter aged 65 or older
- Live in Prince George's County for 5-plus years
- Household income cannot be greater than 40% of the Area Median Income (AMI) <https://www.princegeorgescountymd.gov/departments-offices/housing-community-development/resources/area-median-income-ami-limits>

It is our goal to make sure every resident of Prince George's County has safe, stable housing that allows them to thrive. That's why we are so excited to launch this all-new program to help our seniors. We encourage you to be on the lookout for more information once the application is live.

Volunteering with M-NCPPC, Department of Parks and Recreation



Prince George's County has many ways to volunteer! Individuals and groups can join one-day projects or be ongoing volunteers.

Opportunities include: park police experiences, student service learning hours, summer volunteer groups, court ordered service and adopting a park/trail.

Summer Program Volunteer Opportunities: *Volunteer applications are accepted online March 1- May 1*

Youth may sign up to volunteer at only one Summer Playground or Summer Day Camp. Youth cannot volunteer at a site where younger siblings are registered participants. Youth volunteers must be the required age on/before May 31 to volunteer: Playgrounds 14 years-old and Summer Day Camps 15 years-old.

Youth volunteers ages 15 and older must complete a criminal background check. All youth volunteers must attend pre-service training in May/June. Volunteers are scheduled 12-15 hours per week; transportation is not provided. These volunteer opportunities are approved by PGCPD to earn Student Service Learning Hours.

Park Police Community Volunteer Academy: *Offered annually, one night a week for 8 weeks*

The Volunteer Academy informs participants about the functions of the Park Police and the law. Students receive instruction from experienced Park Police officers, Park Police Volunteer Association members, prosecutors, and others who work in law enforcement or public safety. Topics of discussion include: crime scene management, the role of the prosecutor, current drug trends, gang awareness, and traffic and criminal law. Those who complete the training receive a certificate of completion. Academy participants can also obtain first aid and CPR certifications.

Park Police Volunteer Association — After successfully completing the Volunteer Academy, graduates may become members of the Park Police Volunteer Association (PPVA). Volunteer opportunities include: bike and foot patrol, fingerprinting, and assisting at festivals and bicycle rodeos. The volunteers have proven to be a great asset to the Park Police Division!

Findings will be used to inform future public health programs for Americans. Any data shared with researchers will be limited to what's necessary to evaluate the program and will not include information which can identify you.

- Access to free COVID-19 and flu telehealth visits with a healthcare provider.
- COVID-19 and flu treatment, if prescribed, delivered free to your home or pharmacy.



The #1 Exercise to Do as You Get Older



It's not just about getting off of the sofa! *Squats* are a very beneficial exercise for seniors, but it's essential to use caution and a proper technique.

Squats help improve lower body strength, flexibility, and balance. Here are some considerations and tips for incorporating squats into your exercise routine:

1) Get in position. If you're new to squats, choose a spot where you can hold onto the kitchen counter, a table or another steady surface. Holding on for stability makes it easier to focus on your form without worrying about your balance, says fitness expert Denise Austin.

Set your feet about shoulder-width apart or a bit wider. (If you have hip issues, it's OK to have your legs a little farther apart.) Toes should face slightly outward.

2) Lower into a squat. Keeping your back straight, chest up and heels planted, push your hips back like you are sitting in a chair.

Try to keep your weight evenly distributed on both feet as you do the exercise, with your weight mostly on your heels (not your toes), says the founder of Lori Michiel Fitness, which specializes in senior fitness in the home.

Make sure knees do not extend forward over your toes, which can hurt your knees. If you have knee/hip issues, don't need to do a deep bend. Per Austin, the coming-up part of the exercise is what really builds strength.

3) Repeat. Aim for two sets of eight to 10, at a tempo of two seconds down, two seconds up. Inhale on the way down and exhale on the way up. As your body tires at the end of the set, make sure not to hunch over or let your knees cave in. For the best results, do the exercise two or three times a week.







FACING EVICTION?

Apply for Emergency Rental Assistance

If you are facing eviction due to delinquent rent and you have a court summons, court judgment, or warrant of restitution, you may be eligible for the Prince George's County Emergency Rental Assistance Program (ERAP).



For assistance, call the ERAP CALL CENTER at (301) 883-6504, then press 9

and a customer service representative will help you with obtaining an application.



If you're eligible for assistance:

ERAP may be able to pay up to 18 months of late rent.

If you have already been evicted:

ERAP may be able to assist you with security deposit and up to the first three months of rent once you secure a new rental unit.

NOTE: The Emergency Rental Assistance Program has opened for eviction prevention purposes. Funding is available for eligible renters with a pending court-filed eviction and households with total household income at or below 50% AMI.

The **10** Most Frequent Code Violations in Prince George's County

These and other violations of County Code may result in a fine or other consequences.



- 1. Operating a business out of a residence.** You may not operate a restaurant or café, prepare or serve food for pay, sell goods, store imported products or operate a hair or nail salon or barber shop. These actions pose fire and safety hazards.
- 2. Performing automotive work on a driveway or street.** You may not work on cars on residential streets or in driveways. NO automotive shops may operate on residential streets, in driveways, inside garages or behind houses or apartments.
- 3. Doing unpermitted residential or commercial construction.** Construction projects such as erecting a deck, finishing a basement, remodeling a bathroom or kitchen, building an addition or adding a driveway require permits and inspections from DPIE.
- 4. Placing trash or discarded items to be picked up at the curb days before a scheduled pickup.** Trash and items to be picked up by County trash, bulky trash, Goodwill, Salvation Army, etc., may not be put out before 7 p.m. the night before the pickup.
- 5. Parking commercial vehicles in driveways or on residential streets.** Commercial vehicles should be left at the workplace, not in residential areas.
- 6. Parking vehicles on unpaved surfaces.** You may not park operating or broken vehicles on grass or unpaved areas behind houses or in front yards.
- 7. Failing to adequately maintain a property.** Homeowners or renters are required to cut grass and weeds, prune plants, pick up fallen branches and clear debris from properties on a regular basis. Grass and weeds over 12-inches tall are a code violation!
- 8. Allowing a property to fall into disrepair.** Residents or property managers are required to repair peeling paint, loose siding, ragged gutters, sagging downspouts and broken windows and doors immediately as needed.
- 9. Accumulating junk on residential or commercial properties.** You may not store untagged vehicles, old vehicle parts, junk cars or motorcycles, old appliances, building materials, furniture or garbage on residential or commercial lots. Boats must be tagged and legally parked.
- 10. Leaving abandoned properties unsafe and unsecured violates code.** Buildings must be secured, grass must be cut, other plants pruned, lots cleared of litter and trash removed regularly to prevent accumulation.


